## **Timeline of Events**

Procedural steps that were undertaken in the case of the deportation of the six Turkish nationals on 29 March 2018:

- On 12 and 19 March, a senior official from the Kosovo Intelligence Agency (KIA) went to the Department of Citizenship, Asylum, and Migration (DCAM) of the Ministry of Internal Affairs (MIA).
- On 12 and 19 March, e-mails were exchanged between the Director of the DCAM, the then-Head of the Division for Foreigners of the DCAM, and an Officer for Foreigners of the Division for Foreigners.
- On 19 March, the senior official from the KIA officially informed the DCAM officials that the KIA had the Turkish nationals under surveillance.
- On 22 March, the then-Director of the KIA requested that the then-Minister of the MIA revoke the residence permits of five of the Turkish nationals.
- On 23 March, the Division for Foreigners of the DCAM issued five decisions revoking the residence permits of the Turkish nationals.
- On 27 March, the air transport company Birlesik Insaat from Turkey requested a taxi flight permit from the Ministry of Infrastructure for 30 March, stating that the flight was for business purposes and would have one passenger on arrival and one on departure.
- On 28 March, the air transport company sent another request, changing the date of the flight to 29 March.
- On 28 March, the Department of Civil Aviation of the Ministry of Infrastructure issued a decision approving the flight.
- On 28 March, the then-Director of the KIA requested that the then-Minister of the MIA refuse to renew the residence permit of the sixth Turkish national.
- On 28 March, a meeting was held between the Director of the Border Police, the DCAM Director, the Director of the Directorate of Migration and Foreigners (DMF), and two KIA officers.
- On 29 March the Director of the DMF issued six forced removal orders for the Turkish nationals.
- On 29 March a meeting was held between the Director of the DMF, the two KIA officers, and the two police officers who would lead the operation for the deportation of the Turkish nationals.
- On 29 March, at 7:00, two police teams, divided into six squads, were distributed across two different locations (in the Marigona neighborhood in Lipjan and in the city of Gjakova).
- On 29 March, at 08:00, Messrs. Jusuf Karabina and Mustafa Erdem are detained and transported to the DMF.

- On 29 March, at 9:07, Mr. Osman Karakaya is detained and transported to the DMF.
- On 29 March, at 8:00, the second police team detained Messrs. Kahraman Demirez, Cihan Ozkan, and Hasan Huseyin Gunakan (mistaken for Mr. Hasan Huseyin Demiri).
- On 29 March, shortly after 9:00, the detained persons are all transported to the Adem Jashari Prishtina International Airport.
- On 29 March, at 9:27, police vehicles transporting the detained persons arrive at the airport's VIP zone.
- On 29 March, at 9:50, the documents of the Turkish nationals are controlled.
- On 29 March, at 10:09, the document control is completed. At this time the Head of the Immigration Unit of the Airport, the Director and officers from the DMF and the KIA officers were present.
- On 29 March, at 10:25, the Turkish nationals begin to be transported by the Kosovo Police to the airplane of the Turkish authorities.
- On 29 March, at 10:42, the handover of the six Turkish nationals is completed.
- On 29 March, at 10:50, the airplane departs for Turkey.
- On 31 March, the Prime Minister of the Republic of Kosovo, Mr. Ramush Haradinaj, requests the initiation of an investigation by the State Prosecutor, the Kosovo Police, the KIA, the MIA, the Police Inspectorate of Kosovo, the Civil Aviation Authority, and the Air Navigation Services Agency.
- On 4 April, the State Prosecutor authorizes the Police Inspectorate of Kosovo to conduct an investigation of the case.
- On 4 April, the State Prosecutor authorizes the Special Anti-Corruption Department of the Kosovo Police to conduct an investigation of the case.
- On 28 June, the Assembly of the Republic of Kosovo establishes the Parliamentary Investigative Committee for elucidating the matter of the expulsion of six Turkish nationals.
